

From June to August 2009, an independent online survey was commissioned by Halal Monitoring Committee to understand and gain greater clarity of the scholarly opinions on Halal in the UK. This represented one of the largest surveys of its kind and was undertaken to attain grass root views on halal, directly from UK Scholars.

The online survey was sent to a database of 500 independent Alims, Muftis and Imams all over the UK and responses were received and processed from 282 (56.4%).

The survey remained open for a period of seven days in which responses could be accepted.

Responses were received and processed from 282 Alims, Imams and Muftis, covering a geographical area of over 25 towns and cities, including London, Birmingham, Newcastle, Glasgow, Leicester, Manchester, Blackburn, Reading, Preston and Dewsbury.

The survey asked questions covering issues of the acceptance of mechanical slaughter, the stunning of animals prior to slaughter, recitation of tasmiyah (reciting God's name) and views on the current religious exemptions in UK and European law for Jewish and Islamic slaughter.

### Key Questions Asked

The survey covered several topics. Questions were asked of the respondents to gain an improved understanding of the views currently held with regards halal methods being deployed in the UK.

The following questions were used as the basis of the survey:

#### Q1

Based on your understanding, would you accept "Mechanical Slaughter" as an accepted method of Halal slaughter?

#### Q2

Which method of ritual Bismillah is acceptable in religious slaughter?

#### Q3

Would you accept "Electrical Stunning" as an acceptable method of slaughter in poultry/chicken slaughter?

#### Q4

Would you accept the use of "Electrical Stunning" on red meat (lamb, sheep and cows)?

#### Q5

Which of the methods would you prefer as an acceptable part of the Islamic slaughter process, slaughter with or without any type of stunning?



## response

Based on your understanding, would you accept "Mechanical Slaughter" as an accepted method of Halal slaughter?

Mechanical slaughter is usually used for chickens in the UK. The actual slaughter is done by a mechanical blade (machine) on a conveyor system.



94.68% responded that they would not accept "Mechanical Slaughter" as an accepted method of Halal slaughter. 3.19% indicated that they would accept Mechanical Slaughter and 2.13% were not sure.

Which method of ritual Bismillah is acceptable in religious slaughter?





99.65% of respondents only accepted Bismillah being read on each animal by the individual conducting the manual slaughter. 0.35% indicated that they would accept a recorded Bismillah.



Would you accept "Electrical Stunning" as an acceptable method of slaughter in poultry/chicken slaughter?

For poultry, chicken heads are dipped in electrical voltage water. The intention is to stun the bird prior to slaughter.



89.72% rejected electrical stunning for poultry/chicken slaughter whilst 1.06% accepted it. 0.35% were unsure of the acceptability of electrical stunning. 8.87% would welcome further research on the issue of electrical stunning.

Would you accept the use of "Electrical Stunning" on red meat (lamb, sheep and cows)?



**85.11%** rejected electrical stunning for lamb, sheep and cows slaughter whilst **3.55%** accepted it. **2.48%** were unsure of the acceptability of electrical stunning. **8.87%** would welcome further research on the issue of electrical stunning.



Which of the methods below would you prefer as an acceptable part of the Islamic slaughter?





**98.94%** of respondents indicated that they would prefer slaughter without any type of stunning as part of Islamically acceptable slaughter. **1.06%** indicated that they would prefer Islamic slaughter with stunning.


99.65% of respondents would like the religious exemption for the Muslims and Jewish communities to carry out religious slaughter without stunning to be maintained.

0.35% would like the exemption to be removed.

### response

According to statistics\*, stunning takes place prior to slaughter in the majority of halal slaughter in the UK (maybe up to 90%).

As a religious leader/ representative are you:





94.33% of respondents were upset or angry to read that according to statistics up to 90% of the halal slaughter in the UK takes place after stunning. 4.61% were pleased, happy and content that stunning takes place prior to halal slaughter in up to 90% of cases. 1.06% were not concerned by these statistics.



71.28% of respondents identified their titles as Alims, 17.38% as Imams and 11.35% as Muftis.

1 respondent did not answer this question, whilst some respondents identified more than one location as their city. 21.83% of responses were based in London. 25% of the responses were from cities within the Midlands, including Birmingham, Coventry, Leicester and Nottingham. 34.16% of responses were received from cities in the North of England, including, Batley, Blackburn, Bolton, Bradford, Dewsbury, Leeds, Manchester and Preston.

### Summary of Findings

of the Ulema do not accept "mechanical slaughter" as an accepted method of Halal slaughter; 2.1% want to understand the issue further. 99.7% 90%

stated that Bismillah should be prayed individually by the person conducting the slaughter; not taped nor by person standing on the side.

rejected 'electrical stunning' of chickens; 9% welcomed further research.

rejected 'electrical stunning' of larger animals; 9% welcomed further research.

expressed preference for non-stunned.

believed that the current religious exemptions in UK and European law for Jewish and Islamic slaughter should remain.

### **Conclusions of Survey**

The results of this survey illustrate the views of 282 UK Scholars consisting of Alims, Imams and Muftis, with regards Halal methods of slaughter. A wide geographical area was covered, with over 25 cities and towns in the UK represented.

The key areas of agreement of the majority of the scholars are that mechanical slaughter is not acceptable in any form and that Bismillah must be read on each animal by the individual Muslim conducting the manual slaughter.

On the issue of electrical stunning prior to slaughter, the majority consensus is that the current legal religious exemption from stunning should remain in place in the UK. Indeed the majority were upset and angry that stunning takes place in 80-90% of halal slaughter.
